**Academic Management Positions**

Co-director of the "European Culture and the Media" research group by CEMES (Center for Modern European Studies), Faculty of Humanities, University of Copenhagen, from 2020. CEMES funds the research group for three years between 2020-2022. The research group is engaged with the cultural and media communications of contemporary Europe, their origins and current transformation. We focus on processes of media production, diffusion and use in a transnational context, and the impact of communications policies, including the question of how new media practices shape attitudes and identities of Europeans.

Co-PI of research group on "Media and Communications in Transition Societies," at the Department of Media, Cognition and Communication, the University of Copenhagen, 2015-2016. The global economic and geo-political emergence of BRICS countries (particularly China and Russia), specific social, political and economic problems of Central and Eastern European countries within the European Union, and the particular challenges of post-communist and post-authoritarian democratic transformation in several regions of the world present many new angles and substantial research questions for media and communication studies. A related scholarly challenge is presented by the fact that most theoretical concepts regarding media research had been developed in democratic American and Western European contexts, and their application to problems in emerging countries and transition societies may be problematic. The research group tackled these challenges.

Chair, COST A30 Action of the European Science Foundation „East of West: Setting a New Central and Eastern European Media Research Agenda” (2005-2009). The COST A30 Action, entitled „East of West: Setting a New Central and Eastern European Media Research Agenda”, brought together 70 European media researchers from 27 countries for research workshops and conferences between 2005-2009. The main objective of the project was to develop a European media research agenda with a focus on newly emerging problems of democratic, post-communist Central and Eastern European countries, especially political communication and media law, regulation and policy from a comparative perspective. This collaborative effort between Western and Central and Eastern European researchers also built international networks in order to assist media research and media policy making in the new East and Central European democracies of the EU. The Action's results were published in five academic books.

Academic Director, Center for Media and Communication Studies, Central European University (2004-2009).

Responsibilities included initiating and overseeing projects related to political communication, media research and media policy; representation of the institution in negotiations re international political communication and media research and education consortia (including Erasmus Mundus and EU Sixth and Seventh Framework proposals); coordinating multi-disciplinary and multinational experts groups in media research and policy projects; initiating and overseeing educational programs; in political communication and media studies; academic management in political communication, media research and media policy projects.

Senior researcher and team leader, Independent Study on Indicators for Media Pluralism in the Member States – Towards a Risk-based Approach. A Research Project for the European Commission (2008-2009). The project aimed at developing indicators that will be used by policy-makers and researchers to assess risks to and enhance the state of media pluralism in Europe. The study advanced current policy and academic debates around media pluralism by proposing a multi-dimensional definition of media pluralism (including legal-regulatory, social, and economic indicators) as well as a risk

assessment model. It will be the basis for further empirical studies as well as education on media pluralism. The study was prepared for the European Commission, Directorate-General Information Society and Media; the leader of the research consortium was Peggy Valcke, (Catholic University of Leuven). Work on the study began in January 2008 and was concluded in spring 2009. I served as one of the key researchers, and was responsible for the team that developed social indicators (Work Package 2).

International research workshop and conferences within the COST A30 Action. Between 2005-2009, (co-)organized several research workshops and conferences within The COST A30 Action, entitled „East of West: Setting a New Central and Eastern European Media Research Agenda” that I chaired. These included research workshops at universities or research centers in various locations, including Budapest, Zagreb, Wroclaw, Brno, Milan, and Sarajevo. The international

conference entitled Beyond East and West: Two Decades of Media Transformation After The Fall of Communism, marking the closure of the COST A30 "East of West" Action (2005-2009) was co-organized in cooperation with CMCS at Central European University, the ICA (International Communication Association) and the Annenberg School for Communication, University of Pennsylvania on 25-27 June 2009 at Central European University, Budapest, Hungary. In this conference (that I co-chaired), 250 media and communication scholars from around the globe participated, including distinguished scholars such as James Curran, Elihu Katz, Sonia Livingstone, Barbie Zelizer, Chin Chuan Lee, Monroe Price, Slavko Splichal, and Colin Sparks.

"Politics Online: Comparative Perspectives, Theories & Methodological Innovations." Two conference sessions were co-organized by Nick Jankowski and Miklós Sükösd at the conference entitled THE GOOD, THE BAD AND THE UNEXPECTED: The user and the future of information and communication technologies, Moscow, Russian Federation, 23-25 May 2007. The sessions explored developments regarding online politics in post-communist countries in Central and Eastern Europe, Russia and other CIS countries as well as China and Southeast Asia from the perspective of comparative post-communism. Topics included use of mobile telephones (e.g., SMS) and e-mail during election campaigns, political and social movement actions; web presence (websites and blogs) by political actors; online discussion and chat forums oriented towards politics, public affairs and social movements; Internet censorship and authoritarian measures regarding new media; online privacy; theoretical conceptualizations (such as social shaping of technologies).

"From Secret Service to Public Service." The conference involved a meeting of top European media policy makers and outstanding experts. On one hand, the conference explored issues related to the independence of public service media, i.e., how national media legislation and European regulations can guarantee true political and financial independence for public broadcasters. On the other hand, our intention was to investigate future dilemmas of European public service media. How could public media become successful in the digital environment of the 21st century, when traditional mass media and new media converge and develop new, interactive communication services? How can taxpayers' support of public media be maintained in the era of "pull media"? How can citizens access archival materials in the context of digital convergence? These questions were of particular importance in a period, when European policy makers were revising the Television Without Frontiers Directive, the core element of European audiovisual regulation. The conference featured speeches by Viviane Reding (Member of the European Commission, Commissioner for Information Society and Media), Miklos Haraszti (OSCE Representative on Freedom of the Media), Werner Rumphorst (Director of the Legal Department of the European Broadcasting Union (EBU)), Anna Herold (policy officer in the Audiovisual and Media Policies Unit in the Directorate-General for Information, Society and Media of the European Commission), Matteo Maggiore (BBC's Head of EU and International Policy), Peter Noorlander (senior legal officer with ARTICLE 19), Fritz Pleitgen (Director General of WDR, Westdeutscher Rundfunk (West German Broadcasting Organisation)), Zoltan Rudi (President of Hungarian Television), Tudor Giurgiu (President Director General of Romanian Television), Andrew Taussig (Trustee/Director of Voice of the Listener & Viewer [VLV], a leading advocate body for public service broadcasting in the U.K. and beyond, and Trustee of the London-based International Institute of Communications), Karol Jakubowicz (senior media policy expert), Klaus Unterberger (spokeperson for the Austrian NGO „SOS ORF”), Vincent Porter (President of the European Alliance for Listeners' and Viewers' Associations (EURALVA)).
